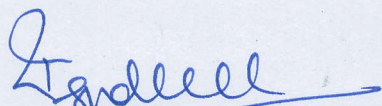

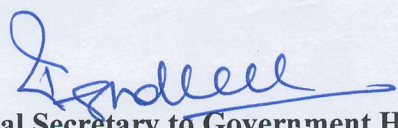

And whereas, it is considered necessary to provide opportunity to all the workers/employees working in all Shops and Commercial Establishments to exercise their franchise.

Now, therefore, in exercise of the powers conferred by Section 28 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other enabling powers, the Governor of Haryana hereby fixes 'Wednesday' the 09-11-2022 for the Districts namely, Ambala, Charkhi Dadri, Gurugram, Karnal, Kurukshetra, Rewari, Rohtak, Sirsa and Sonapat and 'Saturday' the 12-11-2022 for the districts (except for Gram Panchayat Sambhalkha of Block Ladwa, District Kurukshetra) to be the holidays with wages for all the workers/employees enrolled as voters in Zila Parisads, Panchayat Samitis and Gram Panchayats working in all the shops and commercial establishments within the State of Haryana to enable them to cast their votes.
