In exercise of the powers conferred by sub-section (1) of section 44 of the Beedi and Cigar Workers (Conditions of Employment) Act, 1966 (Central Act 32 of 1966), the Government of Kerala hereby make the following rules further to amend the Kerala Beedi and Cigar Workers (Conditions of Employment) Rules, 1968, published as notification No. 232/H1/67/HLD.Dated 2<sup>nd</sup> April, 1968 in the Kerala Gazette No. 17



dated 23<sup>rd</sup> April, 1968, the same having been previously published as notification No.D1/115/2023/LBRD dated 19<sup>th</sup> December, 2024 in the Kerala Gazette Extraordinary No.379 dated 4<sup>th</sup> February, 2025 as required under sub-section (3) of section 44 of the said Act, namely:-

### RULES

- 1. Short title and commencement.- (1) These rules may be called the Kerala Beedi and Cigar Workers (Conditions of Employment) Amendment Rules, 2025.
  - (2) They shall come into force at once.
- 2. Amendment of the Rules.- In the Kerala Beedi and Cigar Workers (Conditions of Employment) Rules, 1968, in sub-rule (1) of rule 8, for the existing Table, the following Table shall be substituted, namely:-

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per rule 8 of the Kerala Beedi and Cigar Workers (Conditions of Employment) Rules, 1968 the fees to be paid for the grant or renewal of a license under section 4 of the Beedi and Cigar Workers (Conditions of Employment) Act, 1966 (Central Act 32 of 1966) shall be as specified in the table. As per G.O. (P) No. 87/2013/LBR. dated 16<sup>th</sup> July, 2013 and published as S.R.O. No. 573/2013 in the Kerala Gazette Extraordinary No. 2158 dated 23<sup>rd</sup> July, 2013 the Government have revised the rate of fees for granting or renewing a license. Now, the Government have decided further to amend the table under the above said rules and to revise the rate of fees with 15% hike as shown above.

The notification is intended to achieve the above object.
